N.B.2. For subsequent calculation of any incremental credits, it is advisable to quote not only the year but also the day and month of all periods of employment.

N.B.3. (a) It is an offence under the Criminal Code for any person to give information which he knows or believes to be false. Anyone who does so is liable to imprisonment for one year.

(b) Any applicant who does any act for the purpose of influencing the Commission either directly or through an Agent will be disqualified for consideration for any post in the Lagos State Civil Service Commission. It will be presumed that a candidate who indulges in canvassing does so because he lacks the prescribed qualification and experience, or considers that he is unable to obtain an appointment on his own merit.
