1. INTRODUCTION

The African Development Bank Group (AfDB) wishes to recruit a **Junior Business Intelligence Developer.** He/She will be responsible for developing and maintaining business intelligence solutions that support data analysis, reporting, and decision-making processes. He/She will work closely with other members of the development team to design, develop and maintain data models, ETL² processes, dashboards, and reports. He/She will also collaborate with end-users to gather requirements and provide support as needed.

2. SCOPE OF WORK

- Work with the development team to design and develop business intelligence solutions.
- Develop, maintain and optimize data models and ETL using tools such as Talend,
 Power Automate, Power Query.
- Create, maintain and update dashboards and reports using business intelligence tools such as Power BI, OBIEE, SAP Web Intelligence.
- Collaborate with end-users to gather and understand their requirements.
- Provide technical support and troubleshooting for end-users as needed.
