# Main purpose of job

As the State Accountability and Health Budget Advocacy Advisor you are responsible for the overall progress of E4A-MamaYe programme objectives in Yobe. You will lead the capacity building of coalitions and other strategic partners within the state, provide technical support on maternal and perinatal death surveillance and response (MPDSR) systems, link health systems data to health budget processes and engage in state-level project management

You will provide technical guidance, training and mentorship on health budget and resource tracking and advocacy for the coalitions E4A works with, and support coalitions develop their transition plans and ensuring progress in the sustainability of E4A's accountability model.

#### About the E4A project

Local health challenges for mothers and children are best understood and tackled by in-country actors and networks that are linked to global initiatives. With funding from the Bill and Melinda Gates Foundation (BMGF) E4A-MamaYe (E4A) fosters sustainable local advocacy partnerships which bring together disparate actors to share information and navigate political processes and interests to make health systems accountable to women's needs. This approach changes accountability ecosystems by radically shifting power imbalances in favor of more equal participation in decision-making. This enables citizens, particularly women and marginalized groups, to exercise their power, elevate policy issues that are a priority for them to the forefront of government agendas, and collaborate to transform health services.

#### Main duties

#### Technical support on RMNCAH and evidence to advocacy coalitions for Yobe State

- Build capacity of advocacy coalitions, such as State Level Accountability Mechanisms (SLAMs)
  coalitions so that they can undertake advocacy on RMNCAH, influence political agendas relating to
  RMNCAH, mobilise financial resources to tackle gaps in quality of health care, and increase
  accountability for commitments in the health sector.
- Mentor coalitions conduct ongoing organisational capacity assessments under the guidance of the Senior Transformation and Sustainability Advisor.
- Work in conjunction with relevant partners to build the capacity of Nigerian advocacy coalitions, opinion-formers and decision-makers to improve accountability in the Yobe state.
- Work with the senior Transformation and sustainability Advisor to mentor coalitions to develop transition plans

## Delivery of E4A-MamaYe work plan in Yobe State

- Develop a work plan and budget for Yobe State, coordinating activities of the programme team and consultants to support the smooth implementation of the programme
- Lead implementation of the Yobe State E4A-MamaYe workplan, coordinating activities with advocacy coalitions, and consultants to support the smooth implementation of the programme.
- Take responsibility for ensuring the workplan is delivered on time and to budget and track progress against indicators, in collaboration with the Senior Evidence Advisor.
- Provide technical input to overall E4A-MamaYe workplans and strategies, suggesting what works to achieve programme objectives

### Sustainability of E4A accountability model

- Support coalitions align plans and activities that would sustain their active role in accountability for RMNCH in the state
- Train new grass roots coalitions on health budget tracking and advocacy
- Facilitate trained coalitions in the mentorship of new coalitions on resource tracking
- Contribute to the set-up (where needed) and functionality of CMPDSR committees and linking emerging data to health budget processes

#### Build capacity on health budget advocacy toolbox at national and subnational levels

- Identify opportunities where E4A-MamaYe Nigeria can support advocacy coalitions use the health budget advocacy toolbox to influence decision making on resourcing health
- Liaise with the Regional Peer Learning Advisor to provide technical assistance to coalitions on tracking implementation of the Basic Health Care Provision Fund (BHCPF) and other PHC initiatives

# Monitoring Evaluation and Learning (MEL) and communications

- Track programme results, identify lessons learned and package these strategically for sharing internally and with partners.
- Facilitate opportunities for cross-learning and sharing of technical skills between coalitions internally and across countries
- Collaborate with the senior evidence advisor on documenting key MEL points
- Liaise with the Senior Evidence Advisor on documenting MEL points against the results framework
- Identify opportunities to share lessons, learnings and materials more widely: for example, through national and international forums and conferences, through the development of Global Public Goods.
